
ORDER

Subject : Exemption u/s. 80-G of the Income Tax Act, 1961, r/w IT Rule 11 AA

It is ordered that donations received by Helpage India Vishokanand Vridha Ashram, Post- Daranagar Ganj, Bijnor, U.P. – 246701, (PAN- AAAAH7020G) shall qualify for deduction u/s. 80G of the Income Tax Act, 1961 in the hands of the donors subject to the limit prescribed. This permission is entered at Sl. No. 307/32 of the concerned register. This permission is allowed subject to the following conditions:

- i. Receipts issued to the donors should bear the number and date of this order.
- ii. The Income and Expenditure Account and Balance sheet should be submitted annually to the Assessing Officer having jurisdiction over the case
- iii. The amendments, if any, made to the Memorandum of Association should be intimated to this office immediately.

2. Non compliance/fulfillment of any of the conditions required u/s 80G read with I.T. Rule 11AA, exemption granted u/s 80G shall become void/cancelled and registration u/s 12AA of the IT Act, 1961 granted to you shall be withdrawn accordingly.

ORDER U/S 12 AA OF THE INCOME TAX ACT, 1961

DATED: 12.09.2013

The application filed by Helpage India Vishokanand Vridha Ashram, Post- Daranagar Ganj, Bijnor, U.P. – 246701, (PAN- AAAAH7020G) and after examining the documents accompanying it and also causing such further inquiries to be made as were deemed necessary in this behalf and after being satisfied about the objects and genuineness of its activities, registration is hereby granted to the aforesaid institution/ trust as prayed subject of the conditions as mentioned below:-


- A. The Society shall apply its income or accumulate for application, wholly and exclusively to the objects of the Society for which it is established and in a case where more than fifteen percent of its income is accumulated, the period of the accumulation of the amount exceeding fifteen percent of its income shall in no case exceed five years.
- B. The Society shall not invest or deposit its funds (other than voluntary contributions received and maintained in the form of jewelry, furniture etc.) for any period during the previous years relevant to the assessment year mentioned above otherwise than in any one or more of the forms or modes specified in sub-section (5) of section 11 of the Income tax Act, 1961 read with the provisions of section 11 (2) (b) of the Income tax Act, 1961.
- C. This approval shall not apply in relation to any income being profits and gains of business, unless the business is incidental to the attainment of the objectives of the Society/Trust and separate books of account are maintained in respect of such business.
- D. Any anonymous donation referred to in Section 115BBC of the Income tax Act, 1961 on which tax is payable in accordance with the provisions of the said section shall be included in the total income of the Society.
- E. The Society/Trust shall regularly file its return of income before the Income tax authority in accordance with the provisions of the Income Tax Act, 1961 along with Income & Expenditure Account, Balance Sheet and Audit Report on prescribed form as per Income Tax Rules.
- F. In the event of dissolution of the Society/Trust, its surplus and assets shall be given to an organization with similar objectives and no part of the same will go directly or indirectly to any of the beneficiaries of the Society/Trust or anybody specified in section 13(3) of the Income tax Act, 1961.

- G. The amendments, if any made to the memorandum of association should be intimated to this office immediately.
- H. The permission granted to the Society shall be withdrawn if it is subsequently found that
- (a) the activities of the Society-
 - (i) are not genuine or
 - (ii) are not being carried out in accordance with all or any of the conditions subject to which it has been approved or
 - (b) the Society has obtained the approval by fraud or misrepresentation of facts.

2. The above application has been entered at **Sl. No. 219/42** in the register for entry of application received under section 12A(a) of the I.T. Act, 1961. Since, the application is received on **18.03.2013** the registration will be effective from **A.Y: 2013-14**

3. The above approval is given for the purpose of section 12AA of the Income tax Act, 1961 only and not for any other purpose.


